

## What is the CB payment in 3 or 4 instalments?

This is a 3 or 4 instalment payment solution with credit fees by **Visa or Mastercard\*** credit card that allows you to spread the payment of the order over 3 debits or 4 debits according to the following schedule:

### For payment in 3 instalments

**1st due date on the day of your order:** 1/3 of the basket amount + 1.4% credit fees when applicable, capped at Eur 9.

**2<sup>nd</sup> due date:** 30 days after your order: 1/3 of the basket amount

**3rd due date:** 60 days after your order : 1/3 of the basket amount.

Credit charges of 1.4% of the order amount will be charged on the first due date, the day of your order.

(\*) To benefit from the payment in 3 or 4xCB

### For payment in 4 instalments

**1st due date on the day of your order:** 1/4 of the basket amount + 2.1% credit fees when applicable, capped at Eur 12.

**2<sup>nd</sup> due date:** 30 days after your order: 1/4 of the basket amount

**3rd due date:** 60 days after your order : 1/4 of the basket amount.

**4th due date :** 85 days after your order: 1/4 of the basket amount

Credit charges of 2.1% of the order amount will be charged on the first due date, the day of your order.

**Eligibility conditions:**

*The amount of your basket must be between 200€ and 3 000€.*

If the amount of your basket is more than €3,000, we invite you to make several reservations.

Be careful, if you are travelling with children under 12 years old, always book them with at least one adult. Indeed, online, it is not possible to book a ticket for a child under 12 years of age if it is not accompanied by an adult over 18 years of age.

**Example of credit in 3 times with fees for a basket to be paid of 300€:**

1 due date of 104.20€.

2 due dates of 100 € each.

Total cost of the credit operation 304,20€.

Conditions in force from 16/08/2016

If you meet all the eligibility requirements (transport date and destinations), the "Payment in 3 instalments by credit card" will be offered to you at the payment choice stage (once your basket has been validated).

**Example of credit in 4 times with fees for a basket to be paid of 200€ :**

1 due date of 54,20€.

3 due dates of 50 € each.

Total cost of the credit transaction 204,20€.



Conditions in force from 26/12/2017

If you meet all the eligibility conditions (transport date and destinations), the "Payment in 4 instalments by credit card" will be offered to you at the payment choice stage (once your basket has been validated).
